

Seven out-of-towners charged

During the past week, seven out-oftowners were arrested for shoplifting, disorderly conduct and unlawful possession of marijuana.

 Police were called to a Rye Brook home at 4:56 p.m. on Tuesday, June 19 after a woman allegedly caused a disturbance leading to the arrest of a visitor.

According to Police Lieutenant Eugene Matthews, a man called 911 on his daughter, who was acting erratically because of depression medication she was taking.

During the evaluation by officers dispatched to the scene, the woman allegedly stated that she still had an active order of protection against an additional party still on site. A radio check confirmed that the order of protection against Rui Zacarias was still active. The 57-year-old Mamaroneck resident was allegedly at the Rye Brook house for unrelated reasons and was unaware that the woman would show up.

Zacarias was charged with criminal contempt for failing to abide by the order of protection, a misdemeanor.

 A Danbury, Conn. woman allegedly shoplifted various merchandise from the Kohl's Department Store at 431 Boston Post Rd. on Wednesday, June 20. Port Chester police were dispatched to the scene at 9:32 p.m.

Annette Bruno allegedly made continuous trips to the fitting rooms in the Intimates department, walking out with less than she came in with, yet the stalls were allegedly found to be clean and empty.

According to the police report, after her second trip to the fitting room, Bruno threw five hangers and two price tags in the garbage. Bruno also allegedly removed a pair of earrings from a jewelry card and then proceeded to throw the empty card in a merchandise fixture.

When confronted by the loss prevention supervisor, Bruno allegedly denied any wrongdoing. However, the supervisor allegedly found the earrings inside Bruno's wallet.

Police later recovered two black bras, valued at \$78, and four pairs of underwear with a value of \$46 from underneath Bruno's outerwear once she was detained at the station.

The 77-year-old was charged with petit larceny, a misdemeanor.

 Two Stamford, Conn. residents were physically removed from Glamour Night Club on North Main Street at 4:31 a.m. on Sunday, June 24 after they allegedly caused a disturbance inside.

According to the police report, a Port Chester police officer witnessed the two 21-year-olds curse and fight security personnel as they were being taken out of the club and then watched as they continued the altercation on the sidewalk.

Both were charged with disorderly conduct, a violation.

• Port Chester police were dispatched to Kohl's Department Store at 431 Boston Post Rd. at 9:04 p.m. on Sunday, June 24 after an 18-year-old allegedly shoplifted \$342 worth of merchandise.

Briana Martinez allegedly roamed through the store and recurrently made trips into the fitting room, carrying in more than she carried out. Martinez then continued to the store's beauty department and selected beauty sponges, which she then proceeded to pay for. Martinez allegedly made no attempt to purchase any other merchandise before exiting the store.

When approached by the loss prevention officer, Martinez voluntarily went back inside the store and allegedly removed leggings, graphics tees, socks, tank tops and a hat from the backpack she carried.

The New Rochelle resident was charged with petit larceny, a misdemeanor.

• A Port Chester police officer executed a traffic stop at the intersection of King Street and Westchester Avenue at 1:32 a.m. on Monday, June 25 after allegedly witnessing a vehicle drive at a high rate of speed, continue past two "Do Not Enter" signs and a "One Way" sign against the flow of traffic.

After he allegedly detected a strong odor of marijuana coming from the vehicle, the officer instructed the car's occupants that the passenger in possession of the marijuana should admit it and give it to him. According to the police report, the front passenger, a Greenwich, Conn. resident, turned over a crushed-up, hand-rolled cigarette and a plastic container, both containing a green leafy substance, to the officer.

The 18-year-old was charged with unlawful possession of marijuana, a violation, whereas the driver, a minor, was issued tickets for driving the wrong way on a one-way street.
